- The bidder should have minimum Three years' experience in the related field like supplying of racks to various Industries like Dairy or related sectors etc.
- Annual Sales turn over should not to be less than 20 lakhs during the financial year 2020-21, 2021-22 & 2022-23.

The aforesaid two envelopes should be put inside an Outer big size envelope duly sealed and this outer envelope again should be super scribed with words Techno- Commercial Bid & Price Bid against our Tender Enquiry and Due Date on and be addressed mentioned in the tender notice.

The bidder shall fill their offers as per given format given in this document & the rate shall include on FOR destination basis, inclusive of all taxes & duties, packing & forwarding charges, transportation, insurance and other incidental charges, loading & unloading charges & GST etc. as applicable.

- The rate shall include loading, unloading, freight, packing, forwarding, transit insurance, GST, all taxes & duties.

**COMPLETION PERIOD:**

- 45 days from the date of receipt of the order.

**VALIDITY OF OFFER:**

- Three months from the date of notification.

**Payment terms:**

1. 60% payment after safe arrival of material at site.
2. 40% after successful commissioning of heavy duty racks at Go down.
3. Payment shall be released within one month of submission of invoices in triplicate.
4. The payment shall be released as per actual main module & add on module installed at site.
5. The bill shall be raised in the name of M/s OMFED, Arilo-Govindpur, Cuttack – 754006. (Odisha).
6. All payments are subject to deduction of statutory dues as applicable.
7. Penalty @0.5 % of order value shall be imposed per week in case of delay in completion of work within the specified time subject to a maximum of 5% of the total value of work.

• **PERFORMANCE SECURITY DEPOSIT:**

- a) A sum of 5% (Five Percent) of the value of work shall be deposited by the successful bidder as security deposit within 15 days.
- b) The Performance Security Deposit can be refunded on submission of a bank guarantee of equivalent amount issued by a Nationalized Indian Bank, valid for 15 months from the date of completion (i.e. 3 months after the Period of Maintenance). The bank guarantee shall be strictly as per the proforma, provided in this tender document. Such bank guarantee shall be released by Omfed after the Period of Maintenance, if all the obligations of the contractor, under the contract have been fulfilled to the satisfaction of OMFED.
- c) The proceeds of the performance security shall be payable to the OMFED as compensation for any loss resulting from the Contractor's failure to complete his obligations under the Contract.
- d) The entire security deposit shall be refunded not later than 03(three) months. from the date of completion of warranty period, if all the obligations of the contractor under the contract has been fulfilled.
- e) No interest is payable by OMFED on the performance security deposit mentioned above.

**Technical Specification:**

- (i) The Godrej heavy duty pallet rack should be made up of Mild Steel.
- (ii) Heavy duty pallets rack having G+2 level of load carrying capacity 2000 kg Each platform of rack should carry two pallets of total load 2 MT. There are no decking panels on each level.
- (iii) The rack should have length 2300 mm, width 1000 mm and level height 1300 mm.
- (iv) Racks shall be used for storage of butter & milk product cartons.
- (v) Our storage Go-down size is mention in commercial bid
- (vi) Chanel Size: 100 mm x 50 mm

- (vii) Angel Size: 75 mm x 40 mm x 8 mm.
- (viii) Load Beam is of 125 x 40 mm box type x 1.6 mm.
- (ix) Connector of load beam is of 3 mm thickness.
- (x) All material will be as per IS-5986 Grade.

**Terms & Conditions:**

1. Bidder should furnish their GST number in their offer.
2. Erase, over writing in the quotation should be strictly avoided and correction (if any) should be signed. Over Writing, Cutting, correction (if any) not attested may lead to cancellation of the quotation.

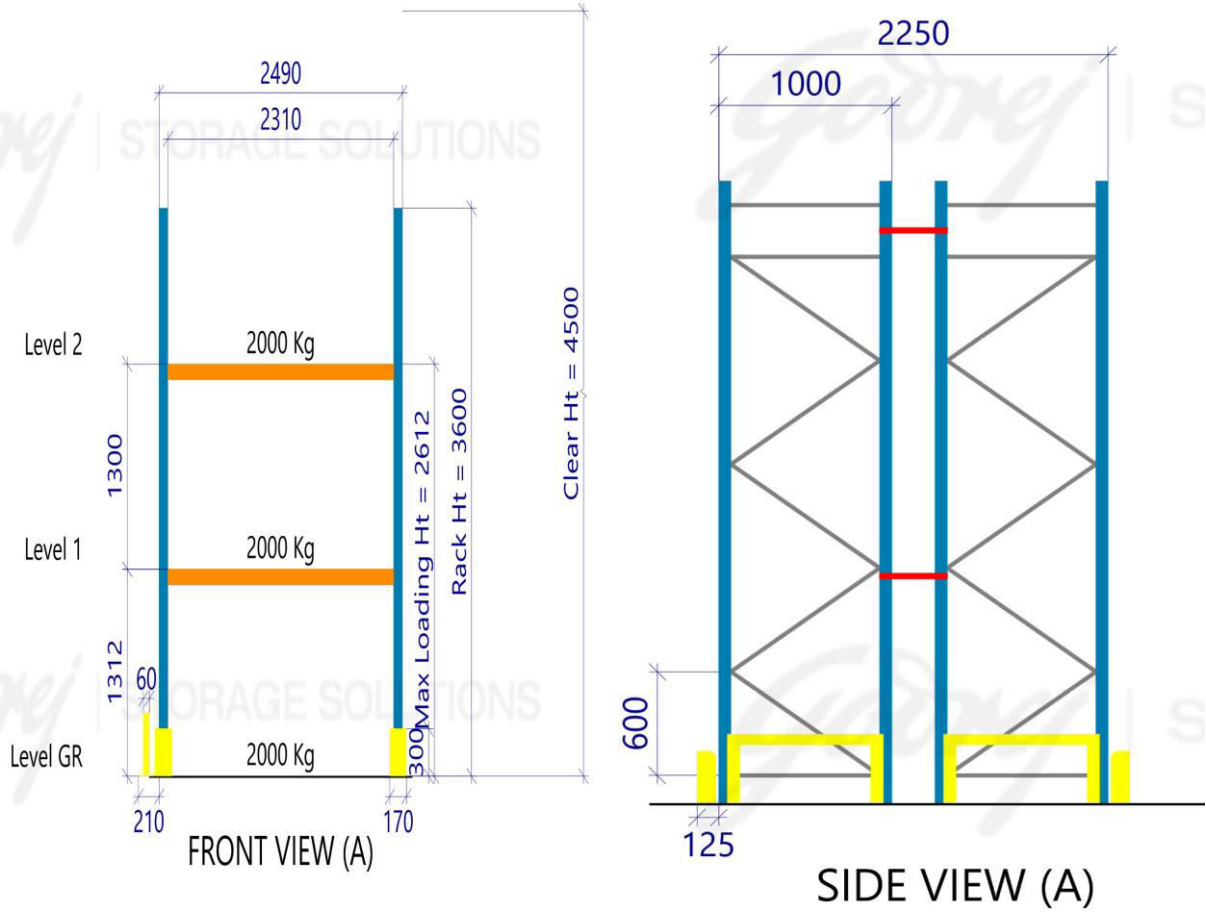

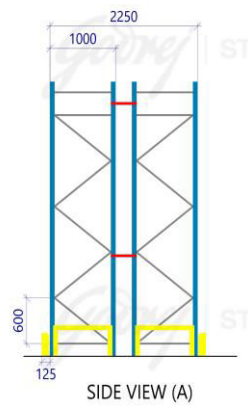
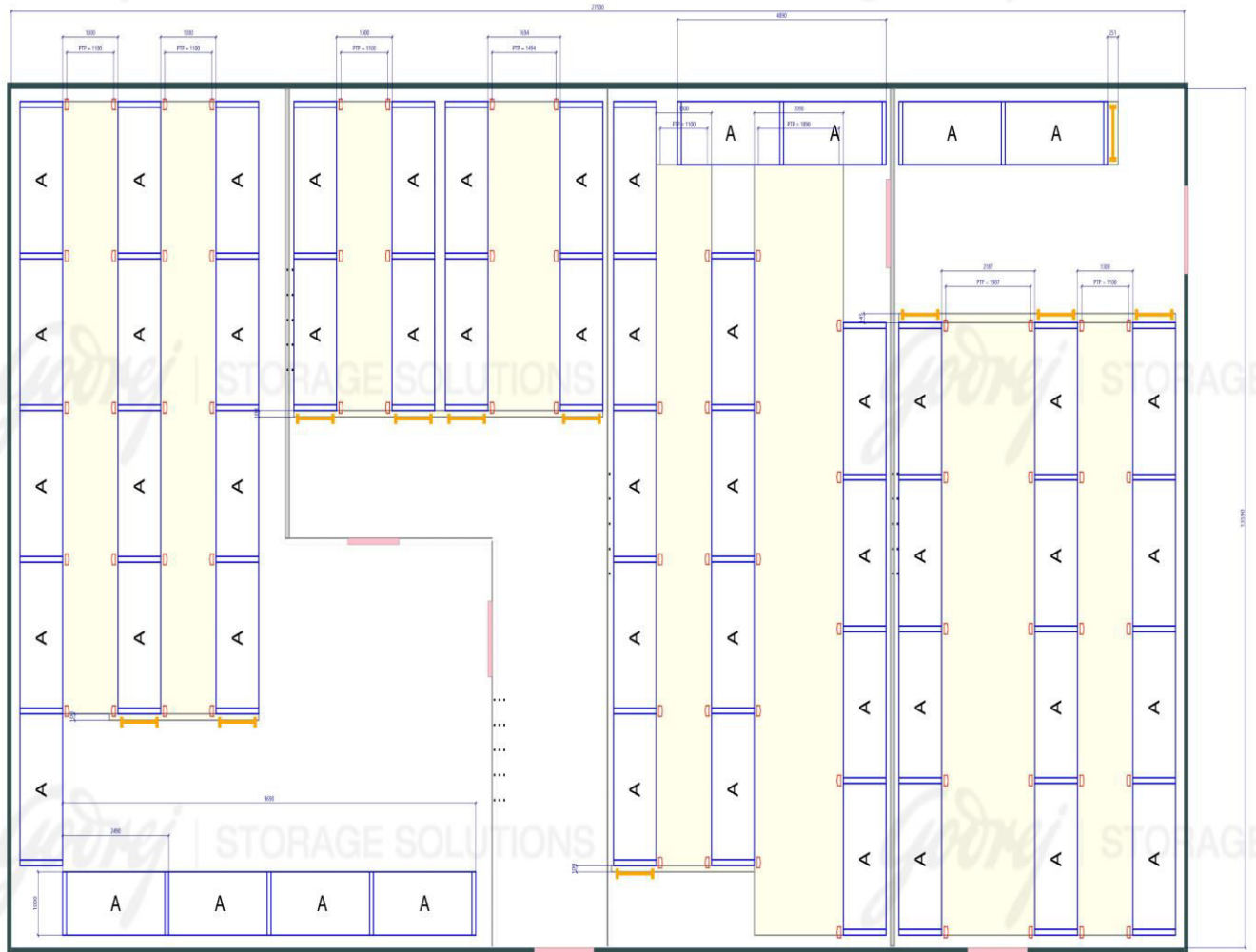
