- The packing material used by the party should be of Food grade type.

The Offer should be accompanied with EMD @1% of the quoted price in shape of Banker's Draft drawn in favour of "The Odisha State Cooperative Milk Producers' Federation Ltd." payable at Bhubaneswar.
