In Bill of Quantity Page:

Basic Rate (Column-7) :- Basic Rate per unit is to be quoted.

Packing & Forwarding (Column-8) :- Total Value (i.e Total quantity of items multiplied with per unit rate for Packing & Forwarding = quoted amount) is to be quoted.

GST (Column-9) :- Total Value (i.e Total quantity multiplied with per unit rate for GST = quoted amount) is to be quoted.

Freight Charges (Column-10) :- Total Value (i.e Total quantity of items multiplied with per unit rate for Freight Charges = quoted amount) is to be quoted.

Transit Insurance (Column-11) :- Total Value (i.e Total quantity of items multiplied with per unit rate for Transit Insurance = quoted amount) is to be quoted.

Per unit price F.O.R destination (Column-12) :- Not to be quoted and it should be filled by **ZERO**.

Per unit Erection Charge (Column-19) :- Total Value (i.e Total quantity of items multiplied with per unit rate for Erection Charge = quoted amount) is to be quoted.
