Eligibility Criteria

1. The manufacturing company should provide after sale service for the supplied Laboratory items.
2. The average annual sales turnover of the manufacturing company detailed out below.

3. The bidder should have supplied Melamine Testing Strips to different Dairy Plants for the year 2018-19 to 2020-2021 & should submit the proof along with the tender documents

4. Delivery Time.

Supply: Within 60 days from the date of acceptance of the order. The delivery sites will be given in the Purchase order.

Testing: within 30 days from the date of Delivery of materials at site.

Terms of payment

- Bills in triplicate shall be submitted along with a copy of P.O
- 75 % on safe arrival of material at site.
- 15 % after successful commissioning/testing.
- PSD @ 10 % of billed value shall be retained by ordering authority for a period of 02 years from the date of handing over and shall be released subject to satisfactory performance.
- Any other statutory deduction like TDS etc. as applicable

Penalty

- Penalty @ 0.5 % of the order value/week basis shall be imposed for delay in execution beyond the time frame. The penalty amount will be Limited to 10% of the order value.

Technical specifications for Melamiae testing Strip

1. Kit must be working based on Immuno-chromatographic technique.
2. Limit of Detection of the Kit shall be within 80 to 120 [g/lit.
3. Kit must be able to detect melamine in raw and processed milk.
4. Vendor shall provide 650- 700 strips.
5. Visual interpretation of the test results shall be possible with appearance of test and control lines.
6. Vendor shall include additional requirements like incubator, auto-pipettes, tips or any other that is required for achieving accurate and reproducible results.
7. Vendor shall provide positive and negative standard to verify the working of kit.
8. Vendor shall provide staggered delivery in two to three shipments on mutually agreeable schedule in a period of 2 years, due to shelf life of strips.
9. Vendor has to conduct verification of the kit to end user before or after the purchase process.
- 10.** Vendor shall provide demonstration and training to end user.
