: GENERAL TERMS & CONDITIONS:

- (A) The period of contract shall be from April 2021 to March 2022
- (B) Since destinations would vary from time to time the interested transporter may quote the rate for the following:
Rate per K.M/MT
 - (i) In 20 MT Capacity vehicle
 - (ii) In 25 MT Capacity vehicle
 - (iii) In 30 MT Capacity vehicle
- (C) As per the requirement the work order shall be placed to the successful bidder and in the work order the details of the lifting points and delivery points, person to be contacted with telephone no., delivery period shall be mentioned. On receipt of the Work Order the bidder has to carry out the job within the specified time.
Other than the States mentioned above if it becomes necessary to transport the materials from the other locations mentioned in the tender documents then the Work Order shall be

placed to the qualified bidder on the basis of rate per KM, per Ton in 20 MT/ 25 MT/ 30 MT capacity vehicle.

- (D) For any dispute the decision of the Managing Director shall be final and binding.
- (E) The legal dispute if arises shall be settled in the Court of Bhubaneswar, Odisha only.

Other Terms & Conditions:

- a) Offer should be valid for a period April 2021 to March 2022.
- b) The bidder has to declare not being blacklisted by any party or Dairy .
- c) All payments are subject to deduction of statutory dues as applicable.
- d) Penalty shall be imposed as decided by the Management for delay in lifting/delivery at the destination point beyond the reasonable time limit.
- e) Cost of material shall be recovered from the pending dues in case of damage/pilferage/theft.
- f) Payment shall be released within 30 days from the receipt of claim/bill along with other required documents through RTGS.
- g) The rate to be quoted towards hiring charges on per KM/MT basis for different vehicles separately.
- h) The hiring charges shall be calculated on the basis of the Log book reading to be maintained by the vehicle Driver and duly certified by concerned officials .
- i) The rate quoted should be based upon prevailing diesel price applicable and shall be revised on pro-rate basis as and when the same is revised by the appropriate authority.
- j) No Detention charges shall be paid at any cost.
- k) All the above stated terms & conditions shall be applicable on reporting of the vehicles with the Driver possessing valid HMTV driving licence at concerned Dairies till release of the vehicles from the Dairy.
- l) The offered price shall be on Present diesel price.
