Bids with EMD amounting **Rs.50,000/-** shall be received up to **14:00** hours on **dt.12.08.2022** & shall be opened on the same day at **15:00 Hrs, dt.12.08.2022.** at Omfed Corporate Office, D/2, Saheed Nagar, Bhubaneswar – 751007 in presence of interested bidders. Bids without requisite EMD & paper cost shall not be considered.

SCOPE OF WORK

for Obtaining ground water clearance from Central Ground Water Board

1. Collection of location details like topographical survey of the area.
2. The detailed hydro geological investigation depicting the present ground water condition in and around the area along with the chemical quality report.
3. Detailed site specific hydro geological investigation keeping in view of the present water requirement/utilization for the plant from ground water source and further demand for future expansion.
4. Hydro-geological report depicting the ground water resources availability within a radius of 10 KM of plant site taking into consideration details of ground water withdrawals made by different major and medium/small scale industries.
5. Collection of hydro geological data, site map, depth of water level, water table contour and aquifer parameters based on pumping test data and chemical analysis.
6. Submission of resistivity survey report of water in different bore well.
7. Preparation & submission of final report, giving presentation at state and Central Ground water board and liaison with authority to obtain NOC.
8. Scrutiny and compilation of documents and preparation of application documents as per CGWA guidelines for obtaining NOC.
9. Compliance of the scientific queries related to the project not requiring any additional study beyond the aforementioned scope of work put by CGWB, Bhubaneswar.
10. Follow-up and facilitation of application at CGWA till obtaining NOC/Exemption clearance.
11. Any point specifically not mentioned but essential for getting the approval shall be included in the scope of work.
12. The required Statutory fees shall be borne by OMFED.

Eligibility and Qualification requirements: -

- The bidder should have in-house hydrogeology experts with at least a post graduate degree in Geology and industry experience of more than three years in handling hydrogeology related projects. Appointment letter and relevant certificate should be submitted.
- The bidder should have minimum two years' experience in execution of such work.
- The bidder should have good understanding of ground water quality and process affecting it in Odisha.
- The bidder should have handled similar projects.
- The bidder should be financially sound and equipped with required manpower and machineries to carry out the work within the scheduled time.

Note: OMFED Management reserves the rights to relax the eligibility criteria if required for execution of work in time to comply the statutory requirement.

- Documents in support of credentials of the party.
- Work order copy and completion certificate from the clients where the party has executed such type of work in last two years.
- Documents in support of availability of in-house hydrogeology experts with at least a post graduate degree in Geology and industry experience of more than three years in handling hydrogeology related projects (CV & other documents to be submitted).
- Audited profit & loss account statement for the year 2020-21& 2021-22.
- Copy of IT return for the financial year 2020-21& 2021-22.
- GST Number.
- Copy of GSTIN / PAN No.
- Credentials in support of execution of similar type of work during last two years. Cost of tender paper & EMD in shape of Demand draft in the name of OMFED payable at Bhubaneswar only. EMD & Paper cost are not exempted in any case. Bids without requisite EMD & paper cost shall be rejected.
- The original bidding document as downloaded by the bidder should be signed & sealed in each page by the bidder as a token of having read, understood & accepted the contents, therein.
