- **TERMS & CONDITIONS** 1. If selected he / she has to set up Milk/milk product Stall in his/her own cost as per the
- specification of Govt.Polytechnic college Ragadi/OMFED, install the required infrastructures (Bottle Cooler, Deep Freeze, Visi cooler etc) and electricity supply on the proposed shop provided by the Government polytechnic College Ragadi, Jajpur.
- 2. He has to obtain the required food license, trade license and should have a valid GST Number. Photo copy of the same is to be submitted along with the application.
- 3. Products will be supplied to the Stall at whole sale price against advance payment as per the advance indent.
- 4. The selected applicant / sub-licensee has to deposit the agreed security amount (quoted in the application) within seven days of receipt of the allotment letter. Minimum Rs 10000.00
- 5. The selected applicant shall pay shop rent Rs 500/- per month as fixed by Government polytechnic College ,Ragadi,Jajpur excluding electric and water charges(as per actual bill).Which will be revised by the Authority Govt.polytechnic College/OMFED and will intimate to the sub-license in due course.
- 6. An EMD amount of Rs.5,000/- (Rupees Five Thousands Only) in shape of demand draft drawn at any nationalized bank in favour of OMFED Salapada Dairy payable at Ananadpur is to be furnished along with the application. The application will be not considered without EMD. The EMD of unsuccessful applicants will be returned after finalization of tender process in their respective address. The EMD amount of successful applicant will be converted as Security Deposit Money. The photo copy of the supporting documents with self signature should be submitted along with the application form.
- 7. He/She has to bear all expenses and statutory liabilities related to Milk, electricity and water charges, maintenance of deepfreezers/ bottle coolers etc.

- 9. The selected party will execute a Tri Partite agreement with Principal Polytechnic & Plant Manager OMFED Salapada Dairy on non-judicial stamp paper of Rs. 100.00 for a period of five years.
- 10. The TRI PARTITE agreement will be initially for a period of 05 year with an option for renewal of the same from time to time as per discretion of OMFED with consent of the concerned college authority on the same or similar terms & conditions or such terms & conditions as may be mutually agreed upon.
- 11. The Federation reserves the right to terminate the Parlour agreement at its discretion by giving one month notice to the third party and invite fresh tender for leasing of the said parlour prior to issue of notice for termination of sub-lease as above.
