SCHEDULE -I:

ELIGIBILITY CRITERIA

- 1. Pest management professional should be current IPCA member.
- 2. Should produce valid pest control license.
- 3. Bidder should have executed similar type of work successfully for at least three years. (Dairy industry, Food Industry-ISO-22000 certified Units)
- 4. Should furnish current clients list in similar type of Industry along with contact person and contact number so as to get the reference.
- 5. Staff should be adequately trained in-house or by outside agency to carry out safe, effective and appropriate pest management/control measures. (Actual person working) must have proof of experience working in Food industry. Training certificate & medical fitness certificate of the staff employed to be provided.
- 6. List of pesticides to be used in the premises are acceptable for its use in food industry and it can be verified by authority for approval.
- 7. Bidder must have Minimum 3 Year Experience in Dairy/Food Industry.
- 8. MSDS of chemicals to be produced.
- 9. Copy of policy for product liability insurance undertaken by the service provider to indemnify the site to be enclosed and the value of which should be more than the estimated contract value (submit document at the time of PO).
- 10. Average Annual Financial Turnover during the last three (03) Years should be at least Rs 5 Lakhs or more.



GENERAL TERMS & CONDITIONS:

Scope of Work:

- 1. Pest Control services including flies, mosquitoes, cockroaches, rodents Lizard and removal of cobweb from OMFED Balasore Dairy complete premises will be carried out on regular basis for 03(Three)years.
- 2. Flies, Mosquitoes, Cobweb & Rodent control will be carried out daily successfully. (Time: 6.00am to 6.00pm or as per production schedule)
- 3. Contract amount will include total expenses incurred on chemicals/ insecticides/equipment and related material.
- 4. Only CIB/FSSAI approved chemicals to be used.
- 5. Expenses incurred on person engaged for carrying out these services shall be borne by contractor, who will further responsible for his service condition or any statuary requirement. The safety measures of the manpower engaged by the bidder is sole responsibility of the bidder. The contractor will have to provide One (01) number of eligible staff on regular basis for the execution of job.
- 6. Work of Pest control shall be executed carefully keeping in mind that no contamination / contact of any harmful chemical/Insecticides with milk & milk products and person working in Plant should occur.
- 7. Monthly bill shall be raised by contractor for which payment be made after verification from concerning officer of OMFED Balasore Dairy after providing signature on work sheet of all departments.
- 8. Before resuming work, an agreement shall be executed by contractor as per rule.
- 9. Contractor will have to provide his own lock & key arrangement along with box for keeping the pest control material.
- 10. Contractors should maintain documents and records as per food safety management system standard (ISO: 22000:2018 & FSSAI) requirements for onsite inspection. Pest operator will obtain signatures of designated authorities in the section after each treatment as per frequency specified in the scope of work and will provide inspection report to concerned about status for its accountability.
- 11. The contractor will have to fulfill all the requirements of the insecticides Act, 1968 (Act 46 of 1968)
- 12. Only permitted insecticides can be used in the Dairy premises.



- 13. Contractor will maintain material safety data sheet (MSDS) for each pesticide has been prepared & display.
- 14. Contractor should prepare rodent map, Keto flash etc. and maintain daily record of observation for audit purpose.
- 15. Period of Contract is initially for one year from the date of Award/Agreement, but the contract may be renewed for one more years, if the performance is satisfactory.
- 16. The quoted rate shall be valid for a period of (03) three year.
- 17. In case of any dispute or differences pertaining to this tender, the jurisdiction of Civil Courts at Bhubaneswar only.
- 18. Decision of OMFED shall be final for any dispute arising out of this contract.

<u>SCHEDULE – III</u>

EARNEST MONEY DEPOSIT:

The bidders shall be required to deposit EMD of Rs.2,000/- (Two Thousand) only along with the tender submission. Without the requisite EMD the tender shall be rejected. EMD in the form of Demand Draft (DD) drawn on any Nationalized Bank in favour of OMFED Balasore Dairy, payable at Balasore should reach physically in the office of OMFED Balasore Dairy, Januganj, Balasore before dt.12.02.2024 at 02.00PM. EMD of successful renderer shall be retained till the completion of the work. No interest will be paid on this deposit for the period during which the deposit is kept with OMFED. EMD of the unsuccessful bidders will be returned within 30 days without interest after completion tender process.

Security Deposit & Dispute Arbitration & final authority.

1. Security Deposit of Rs.15,000/-(Rupees Fifteen Thousand only) shall be deposited by the successful bidder in shape of Demand Draft in favour of OMFED Balasore Dairy drawn on any Nationalized Bank payable at Balasore. No interest will be paid against the Security Deposit. The EMD of successful bidder, converted to security deposit and the biddershall deposit the balance amount within 07days after receipt of work order. If fails to deposit the security the EMD of the bidder shall be forfeited.



At the time of submitting the tender, tenderer shall supply detailed information about their activities in the enclosed form.

2. Penalty:

- a) For 1st time any loss of quality of services/loss of product due to bidder's negligence will be penalized and recovered from bidders bill as per assessment made by Plant Manager.
- b) For 2nd time bidder may be penalized by deducting cost of product plus penalty up to 10% of the loss.
- c) For 3rd time MD, OMFED has power to terminate his services for unsatisfactory performance.
- d) Payment: Payment will be made on satisfactory quality verification of the pest control services within 30days of receipt of the bill.

3. Pest treatment should be given to following premises at both sites.

All Raw Material Godown. Finished Product Godown. Packing Material Godown

DG & Boiler room. Main Process/Product Plant Building.

Utilities Section. Milk/Product Cold Storage.

ETP Plant Coal, firewood storage depot Administration Building

Main Gate. Worker rest room & Canteen

All Furniture etc QC Section.

<u>SCHEDULE – IV</u>

Details as regards to the scope of pest control work

1) HOUSE FLY CONTROL TREATMENT

- (a) Life cycle breakdown and waste food collected. ETP and all likely breeding areas in and out side premises with frequent Inspection and treatment Every fortnightly and as per status. Out side premises smogging has to be carried out weekly as per requirement.
- (b) Adult flies killing Fly resting sites around Main Dairy Plant, Production Block, Administrative Building, Canteen area, ETP etc. Frequency Daily.



2) DIS INFESTATION COCKROACH, SPIDERS, LIZARDS, ANT etc.

Inspection and treatment at such places having pest presence, cockroach hiding, resting places. Frequency – All manufacturing area i.e. Milk pouching, Powder plant and consumer packaging, Ghee, production area (all sections in the Dairy, General store, finished product, Go down - Weekly. All buildings in gutters, chambers, drainage lines up to ETP Plant - Daily.

3) RODENTS (RATS, MICE AND BANDICOOTS).

Step -1

Inspection of entire premises and finding live burrows if any.

- (i) Treatment of burrows by keeping fresh anticoagulant trodenti- cides.
- (ii) Repeating the treatment by interval of 15days till finding live burrows.

Step -2

In relation to step-1fixed bait station boxes will be placed in strategic position sand keeping fresh baits.

- i. Changing the bait with interval of 15 days.
- ii. Applying glue boards and mechanical traps as per needs.
- iii. Suggesting rodent proofing measures, hiding place store move it.

4) PEST CONTROL TREATMENT FOR PLANT

Step –1

Inspection of entire premises for Pest presence.

Step -2

In relation to step-1 Pest control treatment using malathion or DDVP

Step -3

Number of Rodent Stations–30 to 40 or as per need. Frequency - Fortnightly

Step –4

Spraying and Fumigation Frequency - Every Three Months.

- 5) **Termite Control -Treatment if necessary.** Frequency Every Month.
- 6) **Snake Control -Treatment if necessary.** Frequency Every Month.

The Contractor is in the business of providing pest control services for commercial
establishments.
The contractor has agreed to provide the PLANT complete services of pest control at the said
Balasore Dairy and is engaged in processing, packing and marketing of milk and milk

products at the said PLANT under the terms and conditions set out herein:

NOW THEREFORE, IT IS HEREBY AGREEDBY AND BETWEEN THE PARTIES AS

FOLLOWS.

1. Duties and responsibilities of the Contractor: The contractor shall be responsible for the

following duties at the Plant located at Januganj, Remuna, Balasore (hereinafter referred to as

the Balasore Dairy) and is engaged in processing, packing and marketing of milk and milk

products at the said PLANT).

1. The contractor must have specific pest control measures as applicable to a food

manufacturing site, must ensure that the treatment itself does not expose food to risk of food

poisoning.

2. All chemicals, methods and measures used must be approved and registered by the Central

Insecticide Board, GOI.

3. The contractor would use the chemicals in either oil or water base formulations. Any

change in the chemicals would be intimated to the Plant Manager.

4. The contractor would provide trained operator/technicians for regular pest control service.

5. Contractor must provide copy of M.S.D.S. for the chemicals used by the factory.

6. The schedule for the various services will be adhered as per frequency given in the scope

of work.

7. If at any time or times after the initial treatment but before the next due date 'Pest'

reappear, the contractor would carry out the necessary treatment without any additional cost.

8. Period of Contract is initially for one year from the date of Award/Agreement, but the

contract may be renewed for one more years, if the performance is satisfactory.

Scope of work:

1. House hold disinfestations/Disinfestations of COCKROACHES, SPIDERS, LIZARDS,

ANT, SNAKES etc: The contractor would carry out disinfestations operation to control

cockroaches, red and black ants, silver fish, termite in the form of an insecticidal spray in the

plant campus. The contractor must carry this operation once in a month.



2. Rodent control:

- a) The contractor would use 'ROBAN' single dose anti-coagulant bait.
- b) The treatment would cover the plant campus by placing baits in rodent burrows/harborage so as to keep the premises free of any rodent activities and to avoid migration within the building.
- c) The contractor will fix rodent bait station along with the external perimeter of the plant building and campus.
- d) The production and packing area where poison baiting is not advisable will provide eco-friendly nontoxic glue boards.
- e) The baits/traps must be placed along the external perimeter at strategic point.
- f) Frequency of this treatment will be once in a week to replenish the baits/traps.

3. FLY CONTROL (RATS, MICE AND BANDICOOTS):

- a) The contractor would spray the approved and recommended chemicals in and around the plant area which includes non-production areas like Lab, Ghee, Butter room, manholes, corridors, varanda etc. except inside the packing/ production area, boiler, garage, store, time office, scrap yard.
- b) Milk pouching, Powder plant& consumer packing, Ice-cream plant, Ghee, I.P., General store, finished product section, ETP and all likely breeding areas in the premises. Sub-contracting/non-assignment: The contractor hereby agrees that this agreement shall be performed by the contractor itself and under no circumstances the contractor shall subcontractor assign the same to any third party.
