Sub: Status of milk sent to outside State Dairies for Bulk Sale & Conversion

During the year 2019-20, surplus milk was sent to outside State Dairies for Bulk Sale and conversion into SMP & Ghee from our different Dairies looking into their surplus situation. From April'19 to Aug'19 total 22,27,730.0 Kg. of milk has been sent to outside State Dairies as Bulk sale. From April'19 to Aug'19 total 40,64,470.0 Kg. of milk has been sent to outside State Dairies for conversion to SMP & Ghee.

Sub: Flexibility in revision of Cattle Feed Price by OMFED

The procurement price of cattle feed ingredients like De-Oiled Rice Bran (DORB), Maize, Rice Polish, Dried Distilled Grain solution (DDGS), De-Oiled Mustard Cake (DOMC) etc. fluctuates frequently during a year. Sometimes, the cost of raw materials are exorbitantly high and during harvesting season, the cost of raw materials goes down. It was proposed to authorize Managing Director, Omfed to fix up the sale price of cattle feed as and when required looking in to the cost of raw materials.

Besides approving the proposal, the Board members requested for supply of OMFED cattle feed on regular basis. It was also decided to produce cattle feed (mass/pelleted) with 20% crude protein. The cattle feed price shall be revised from time to time on the basis of increase in input cost.

Sub: Supply of Relief Cattle Feed to Cyclone(FANI) affected districts.

During 1st week of May, 2019, the Cyclone (FANI) struck Odisha Coast by which the District like Cuttack, Puri, Jajpur, Jagatsinghpur & Kendrapara were severely affected. As per indent received from the Office of the Special Relief Commissioner, Odisha / District Collectors / Director, AH & VS, Odisha, Cuttack, OMFED was asked to supply Relief Cattle Feed to the affected Districts. Total 2006.50 MT of Relief Cattle Feed has been supplied to Cyclone (FANI) affected districts during 1st week of May'2019 as per indent received from SRC, Odisha.

Sub: Implementation of Incentive Scheme for Secretaries of DCS

Looking into the drastic fall in milk procurement, Omfed has introduced an Incentive Scheme for the Secretaries of Dairy Cooperative Societies. A Base-line of milk procurement has been fixed for Milk Unions as well as Primary Milk Societies, basing on total milk procurement of October'2019. An incentive of Rs.2/- per Kg. of milk shall be released to the Society Secretaries for the additional milk supplied during December, 2019 over and above the Base-line fixed through Milk Unions and Dairy Cooperative Societies.

Sub: Turnkey execution of 20,000 Ltr/day Dairy Plant at Kendupatna RMC, Nischintakoili Block, Cuttack by M/s. Engineering Projects India Ltd., Mumbai

Project proposal of 20,000 Ltr. Capacity Dairy Plant at Kendupatna in Cuttack district at a project cost of Rs.1285.20 lakhs was approved by RKVY on 20.07.2018. Resolution No.1991

Resolution No.1992

It was decided during the 105th Meeting of the Board of Directors held on 20th February'19 to extend 0.15 Paise per ltr to the respective Milk Unions as solid cost. Calculation to be made from February'2019 to August'2019 and after looking into the Profit for the year 2019-20 it will be paid by end of the financial year. The total payable amount will be around Rs 1 Crore 50 Lakhs.

Resolution No.1993

Unions are directed to send proposals of the DCS eligible for registration with immediate effect. P&I division will take action on it. The pending proposal of Registration shall be put up by P&I division for approval of ARCS cum MD,OMFED within a month.

Resolution No.1994

Regarding Audit of societies and Milk unions as the Audit in some societies and Unions are pending for several years it was decided that the Milk Union may request AGCS/AAGCS(Asst. Auditor General of Co-op Societies) at District Level to provide Auditors for the purpose or recommend empanelled Chartered Accountants to final their Audit. If this is not possible then the Unions can request the Federation and Federation will recommend the name of Chartered Accountants empanelled by AGCS. The payment for Audit shall be made by respective societies and Milk Unions.
