1. Sealed tenders are invited from bonafide Dealers/Stockiest/Distributor of dairy products to sale Cow Butter/SMP/Ghee on “as is where is basis” available at Arilo dairy, Cuttack, Omfed Training Center (OMTDC) & Hazipur, Bihar. The tender is invited on-line through ‘e’-procurement of Govt. of Odisha web Portal <https://tendersodisha.gov.in>. The bidders should have the necessary portal enrolment with his own Digital Signature Certificate.

2. The bidders are required to submit bids for the following items.

6. **Techno-Commercial Bids received online shall be opened on 13.08.2024 at 03.00 P.M.** in OMFED Corporate office in the presence of the bidders. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

7. The technically qualified bidders will be informed to open for evaluation of the commercial bid.

8. Co-Operatives, Govt. bodies, NSIC and MSME registered firms are exempted from submitting required EMD.

9. OMFED in its own interest may opt for any other procurement mode/system simultaneously along with this e-Tender process if required without assigning any reason thereof.

10. The corrigendum/amendment to this notice if required shall be published only in the OMFED web site <https://www.omfed.com> and will not be published again in the newspaper.

11. The Managing Director, OMFED reserves the right to accept/reject any or all the bids without assigning any reason thereof.

12. OMFED reserves the right to increase or decrease the quantity of the tendered items or period of delivery as per the requirement of the Federation

Eligibility Criteria

- 1) **Cost of tender document is Rs 590/-** including GST.
- 2) **EMD Rs 2,00,000/- submitted with Technical Bid, which will be refund.**
- 3) **Successful bidders must be deposited Rs 3,00,000/- towards Security Deposit of each commodity before placing the Order.**
- 4) The bidder must attach self-attested and sealed copy of GST registration certificate, PAN card, FSSAI license, Certificate of Incorporation for Companies, Partnership Deed/ Other Registration certificate in proof of organization in the technical bid.

GENERAL TERMS AND CONDITIONS:

- 1) Tender bids are invited for sale of Cow White Butter/SMP/GHEE on as is where is basis and "no-complaint" basis. Any quality/quantity issues will not be entertained post sale.
- 2) Bidders are advised, before participating in the tender, that they must visit or contact to concerned plant person for any enquiry on quality of butter.
- 3) The sale shall be against 100% advance payment only within specific time frame in consultation with the Head of the respective Units concerned as per the rate contract to be effected from the date of sale order issued.
- 4) All the quantity declared is approx. basis. This may increase or decrease at the time of final lifting.
- 5) The tender quantity may be increased or decreased.
- 6) The rates must be kept valid up to minimum One month. Any change in address of the tenderer shall forthwith be intimated to the Federation. The lift period may be extended as per mutual consent.
- 7) Lifting of materials will be arranged by the party within specific time frame in consultation with the Head of the Unit or as per schedule to be reflected in the work order. However, the buyer must have been prepared to lift the agreed materials in his favor within 30days of the lifting schedule. **The Security deposit will be forfeited in case the selected party will fail to lift the agreed materials within the scheduled period.**
- 8) The GST rate, TCS or any other statutory Duty/Tax/Levy/Charge etc. will be applicable and payable by the Buyer as prevailing on the date of actual physical delivery of materials.
- 9) The buyer should lift the White Butter from our premises by their arrangements. All the types of weightment /counting or measurements and loading would be done in presence of our authorized person and shall be considered as final.
- 10) The weightment taken at our Dairy/Plant is final & binding in nature and items once lifted from dairy /sold cannot be taken back.
- 11) For the purpose of removing the materials, the successful Bidder shall employ or engage only his / their own personnel at their own cost and shall keep the Seller fully indemnified against any claims whatsoever including claim for wage, injuries, compensation, death etc. They must follow all safety rules in this connection wherever applicable. The buyer shall be liable for any violation of such rules

- 12) The bidders shall not be allowed to repack, resize the materials inside the Plant Premises without prior approval from Managing Director, OMFED.
- 13) The bidders should not transfer the offer awarded to him/her/them to others and also no sub-contract is allowed. In case of deviation of any of the conditions, the offers shall be cancelled besides forfeiting the deposit amount and imposing penalty as decided by SELLER or its authorities.

- 15) The Managing Director, OMFED reserves the right to forfeit the EMD of the bidder, who violates any terms and conditions of the tender document.
- 16) Tender papers handed over to the Federation duly signed and sealed in each page completed in all respect will be considered as the property of the Federation and the party does not right to get back the documents furnished therewith.
- 17) The decision of the Managing Director of this Federation in each and every respect shall be final and binding upon the contractor and he is the sole authority to finalize any dispute regarding the scrap sale contract.
- 18) The Bidder(s) shall have no right to issue any addendum to these Special Terms and Conditions or Buyer Specific Terms and Conditions to clarify, amend, supplement or delete any of the conditions, clauses or items stated therein.
- 19) The Managing Director reserves the right to split the orders or reject any or all tender papers without assigning any reason thereof.
- 20) The quantity, quality, measurement and condition of the materials indicated are all approximate. Participation and bidding by anyone in this sale shall be treated as conclusive evidence of the fact that the party has inspected the materials offer for sale and satisfied himself in all respect regarding quantity, quality, measurement, weight and condition of materials, taxes and duties, local working condition and other extraneous factors and principle of Caveat Emptor (let the buyer beware) will apply.
- 21) **ARBITRATION:** In the event of any dispute and difference arising between the Purchaser and Seller of any of the terms & conditions of e-auction, the provisions of the Indian Arbitration Act, 1996, and the Rules amended time to time there after shall apply to such Arbitration. The award passed by such Sole Arbitrator shall be final and shall conclusively bind all the parties.
