The interested bidders may purchase the tender paper from OMFED Dairy, Cuttack on payment of Rs.1180/- (Rupees one thousand one hundred eighty rupees only) per set on payment of cash or in shape of DD drawn in favour of OMFED, payable at Bhubaneswar, **from dt.21.01.2023 to dt.15.02.2023** in office days, within 10AM to 4PM. TECHNICAL BID:

Supply of one no Battery/Electric pallet Stacker minimum capacity 1.5MT.

Eligibility Criteria:-

- a. The bidder should have minimum Three years' experience in the field of manufacturing / Supplying of Electric battery operated Pallet Stackers.
- b. Annual Sales turn over should not to be less than 10 lakhs during the financial year 2019-20, 2020-21 & 2021-22.
- c. The bidders have the valid AUTHORIZATION / Dealership certificate of the manufacturer.

Technical Specification of Pallet Stacker:

- a. The pallet stacker should be battery/electric power operated.
- b. The stackers should be of Toyota, Godrej, KION, or any reputed brand.
- c. Mode of operation: The equipment should be standing operation type / Rider.
- d. Capacity: Minimum 1.5MT at 600mm load centre
- e. Battery: Minimum capacity: 24V/225AH
- f. Motor : Minimum capacity: Drive 1.3KW & Hydraulic / pump motor 3KW
- g. Break Electro Magnetic break & Tyre should be tubeless Polyurethane
- h. Steering: Full function with control handle.
- i. Fork length: Minimum 1150mm.
- j. Mast type: 2stage CVM.
- k. Lifting height requirement: minimum 3000mm
- l. Overall Raised height: Maximum up to 4000mm
- m. Overall height lowered: Maximum 2110mm
- n. The width across forks (outer-outer) 570mm or above
- o. Right angle stacking Aisle width: maximum 2550/2990 mm (without platform / with operator platform)
- p. Chassis width: minimum 1344mm
- q. Charger: 8hr double rate charger
- r. Inclusive of all standard accessories like operator platform with side restraints, Battery discharge indicator, Ramp hold facility, side extraction with battery compartment rollers, load back rest & etc

Terms & Conditions of Technical Bid:

1. The offers should have the detailed address, name of contact person, Phone no, mobile no of the bidders for early communication of information.
2. The bidder should have the experience of at least 3years for supply & manufacturing of stacker.

3. The bidder should attach the certificate/work order/purchase order copy of the reputed establishments towards successfully supply of the pallet stackers.
4. The Bank draft no, date and amount towards Tender paper & EMD cost may be mentioned. The cost of EMD will be refunded to the unsuccessful bidders after completion of the tender process at the earliest. The EMD cost of qualified bidder is adjusted in Security deposits or refund after receipt of performance deposit @ 2% . .
5. Delivery period: The bidders must have to execute this order within 60days after placement of purchase order / work order. In case failure to supply in time 0.5% of the order value per week will be deducted subject to 10% of the order value may be deducted as penalty for delay of delivery.
6. Delivery address: The bidders have to deliver the same at our OMFED Dairy, Arilo, Govindapur, Cuttack 754006.
7. Validity of the offer: The bidders must have valid their offer for three months from the date of opening of the tender i.e from dt.16.02.2023.
8. Warranty / after sales service: The bidders must have to give minimum one year's warranty from the date of operation of the pallet stackers and undertaking (in letter head) for after sales service of the stackers.
9. The bidder shall provide GST Registration certificate along with GST return (GSTR -1 & 3B) for last 3months.
10. The bidder shall provide copy of PAN with IT return for the FY 2019-20, 2020-21, 2021-2022.
11. The bidder shall not be blacklisted by any other organization / by OMFED
12. Legal Jurisdiction: Legal dispute if any arising out of this process, shall be subject to such courts exercising civil jurisdiction over Bhubaneswar only.

No interest is payable on the Security deposit. Or The bidders may also deposit the same amount of bank guarantee as security deposit towards releasing of their full billing amount. 5. Payment term: The payment of the bidders will be released after supply & operation of the pallet stackers within 20days subject to deduction of security deposit of @ 2% or submission of bank guarantee in same value.
6. Payment shall be released subject to any deductions of statutory dues, Penalty & Performance security if any.
