## TECHNICAL SPECIFICATION FOR SUPPLY, INSTALLATION, TESTING & COMMISSIONING OF MULTI CYCLONE DUST COLLECTOR FOR 1MTPH COAL FIRED BOILER

The cyclone separators shall be used for the existing Coal fired boilers of capacity -1MTPH / 10.5Kg/cm<sup>2</sup>. The cyclone separator shall be used to arrest the dust / un-burnt coal particles from being exhausting out of the chimney.

The following items are to be supplied by the bidder.

- 1. Multi cyclone dust collector
  - MOC MS for cyclone body
    - Heat resistant stainless steel (SS) / CI for internal cyclone nozzle
    - Nozzle should incorporate draught swirls
- 2. Flue gas Inlet x outlet nozzles 350 x 350mm (as per actual requirement at site) (square / rectangle as per site condition)
- 3. Rotary air lock valve for dust discharge at bottom with suitable electric drive
- 4. Cyclone body to be self supported on independent leg support.
- 5. Required ducts to be provided for modification / replacement between boiler flue gas outlet to suction of ID fan and from outlet of ID fan to flue gas chimney.
- 6. Civil foundation for grouting the legs and support base for Multi dust collector / any other civil work shall be in the scope of the bidder.
