1. The Odisha State Cooperative Milk Producers' Federation Ltd. (OMFED) invites sealed offers from State Milk Cooperatives / Milk Unions / Private Dairies for Bulk sale of Pasteurized Mixed Milk from our OMFED Dairy, Arilo, Sambalpur Dairy, Balasore Dairy and Bhawanipatna Dairy.
2. The bidders are required to submit bids for the following items.

The tender paper cost & EMD in the form of DD issued from any Nationalized/ Scheduled Bank may be prepared in favour of OMFED, payable at Bhubaneswar in original and Photo Copy of all documents required as per eligibility criteria shall be deposited in sealed envelope at Omfed Corporate Office, Saheed Nagar, Bhubaneswar during working days.
4. Non submission of cost of bid document and EMD within the period shall debar the party from participating in the tender system.
5. Bids shall be received on or before schedule time i.e. 22.05.2025 at 05.00 PM.
6. The **Techno-Commercial Bid of tender document shall be opened at 11.30 AM on 23.05.2025 at Omfed Corporate Office, Saheed Nagar** in the presence of the bidders.
- 7 Co-Operatives, Govt. bodies, NSIC and MSME registered firms are exempted from submitting required EMD.
8. OMFED in its own interest may opt for any other procurement mode/system simultaneously along with this e-Tender process if required without assigning any reason thereof.

10. Legal disputes if any concerning the required goods supplied & matters related thereto shall be subject to Jurisdiction of such court as exercising civil jurisdiction of Bhubaneswar only.

1. ELIGIBILITY CRITERIA

1. The bidder should have required numbers of RMT for transportation of milk with National Permit.
2. The bidder should have PAN and GST No.
3. The bidder should not adopt unfair means for allotment of said Work Order.

2. OFFER SUBMISSION:

- 2.1 The offers should be submitted within scheduled time & date.
- 2.2 Tenders shall be submitted in sealed envelopes separately for Commercial.
- 2.3 The offers received through E-mail will not be considered.
- 2.4 The **rates should be quoted in prescribed format** only.
- 2.5 The party should clearly mention the correspondence address, fax/e-mail/ telephone nos. Any change in the address should immediately be notified to the OMFED and correspondence thereafter will be made at the changed address.

3.0 TERMS & CONDITIONS:

- 3.1 Transport will be arranged by respective purchaser.
- 3.2 Your quality control representative is allowed to check the quantity and quality before dispatch of milk from our Dairy Dock.
- 3.3 The test report of the dispatched dairy shall be final for milk bill payment.
- 3.4 No complain relating to the quality of milk after dispatched shall be entertained by OMFED.
- 3.5 The transit insurance will be done at your level.

Seal & Signature of the bidder

- 3.6 OMFED shall not be held responsible for pilferage, theft, road accident, breakdown of vehicle etc. after dispatch of milk.
- 3.7 (a) For Co-operative Milk Union buyer all payments shall be made at Ex-Unit of OMFED within 1 days.
- (b) For Private buyer all payments shall be made in advance before loading of tankers.
- 3.8 The sale of pasteurised Mixed milk is subject to availability of excess milk at Dairy level.
- 3.9 The bidder should not sale any milk inside the State of Odisha.
- 3.10 Milk supply shall be made on Ex-Dairy/Plant basis.
- 3.11 The quantity of milk to be despatched 60,000 to 80,000 LPD subject to availability of surplus milk.
- 3.12 Quality & Quantity of despatch Dairy/Plant shall be final.
- 3.13 E.M.D. of Rs. 20,000/- (Rupees Twenty thousand only) for Private buyers to be submitted through RTGS and No EMD for State Cooperative Federation/its affiliated Milk Unions & they will simply forward the willingness. E.M.D. exempted for State Co-Operatives and MSME.
- 3.14 The endorsement of Way Bill/Road permit attached with the document of consignment at Interstate & Check Post shall be the complete responsibility of the transporter which will be submitted at despatching Dairy before next loading.
- 3.15 The offer shall be valid for 12 months from the date of placement of order.
- 3.16 The bidder must produce original tollgate slip as a proof of delivering the milk outside Odisha.
- 3.17 Amount of Tender cost and EMD may be remitted through RTGS as per following Bank details.
