DETAILED NOTICE INVITING TENDER

INTRODUCTION:

"The Orissa State Co-operative Milk Producers' Federation Limited" (OMFED) is an apex level Dairy Cooperative Society registered under Cooperative Society Act – 1962. Under this Angul Dairy is a semi-automatic 30KLPD capacity plant processing the raw milk and producing milk and milk products for their valuable customers. There is One Boiler no OD-69, capacity 0.6 MT make Rakhoh.

SCHEDULE - I

TECHNICAL BIDS:

Details of Boiler: Name of Boiler: OD-69. Capacity: 0.6 Ton Make: Rakhoh.

A: Eligibility Criteria:

- 1. The bidder should have at least 03 years' experience in supply, replacement and refixing of IBR certified Boiler Tubes or spare parts of the boiler. The bidders need to submit the earlier work orders for supply of the boiler spare parts or tubes to any organization.
- 2. The average annual sales turnover of the bidder should not be less than Rs. 2.00 lakhs for the last three financial years starting from 2022-2023, 2023-2024 & 2024-2025.
- 3. The bidder shall furnish a copy of the Income Tax return for the financial year 2022-2023, 2023-2024 & 2024-2025.
- 4. The bidder shall also provide their permanent A/c No. Income Tax (PAN).
- 5. The bidder must have GST registration.
- 6. The bidder must submit proof of all above otherwise tender will be rejected.
- 7. In case the day of opening of tenders happens to be a holiday, the tenders will be opened on the next Working day.
- 8. The time and place of receipt of tenders and other conditions will remain unchanged.
- 9. The bidder should enclose an undertaking with regards to non-black listing by any Govt or Semi-Govt or PSU or Cooperative institutions.

B: Submission of bids.

- 2.1 The bidders shall seal the tender documents duly marking the envelopes as Name of the work with Address.
- 2.2. The envelope shall:
 - (a) The cover shall contain all documents as per Volume-I and the Price Bid Volume-II, shall be sealed.

- (b) Tender to be addressed to OMFED at the following address:

- (c) Bear the name of the work, bid reference, and the date of opening as mentioned in tender notice.
- 2.3 The envelope shall indicate the name and address of the bidder to enable the bid to be returned unopened in case it is declared "late"
- 2.4 If envelope is not sealed and marked as required by Para. 2.2, the OMFED will assume no responsibility for the bid's misplacement or premature opening.

3.0 Deadline for submission of bids.

- 3.1 Tender Document may be either submitted in person or may be sent by registered post with acknowledgement due, so as to reach within stipulated date and time as mentioned in tender notice / cover page.
- 3.2. Tender Document must be received by the OMFED at the address specified under para. 2.2 not later than the time and date specified for receipt of the bids as indicated in the Tender Notice, or as extended by OMFED.
- 3.3 The OMFED may, at its discretion, extend this deadline for the submission of bids above, in which case all rights and obligations of the OMFED and bidders previously subject to the deadline will thereafter be subject to the new deadline as extended.
- 3.4 The Federation will not be liable for any postal delay in delivering the tender when the tenders are sent by post.

C: General Terms & conditions:

The bidders are requested to Note the following General conditions of the tender & Submit the required Documents:

- 1. The Period of contact as per the Tender will be for 4 months and the material requirement during this period is to be supplied by the bidders as per the approved tender rate.
- 2. Brand name of the items are to be indicated. Where the brand name is not possible the source of manufacturing may be furnished. Manufacturers will be given 1st preference. Authorized distributors will have produce distributor certificate from their principal. Federation reserves the right to contact some original reputed manufacturers to know the genuinely of the items & rate offered for their items by their distributors.

- 3. The Technically qualified bids would be eligible for opening of the price bid.
- 4. List of the institutional, customers and Xerox copy of their purchase order may be attached.
- 5. The bid of the black listed party or supply defaulted party shall not be accepted.
- 6. The Federation is not bound to accept the L₁ rates & reserve the right to negotiate the rate with the bidders with reputed brand bids and may ask the original manufacturers to supply items them through their distributers in specially discounted rates for our organization.
- 7. **Risk Purchases:** The Federation reserve the right to purchase the relevant item from open market at the cost and risk of the suppliers in case it is not supplied in time. In such case, the differential cost, if any, shall be recovered from dues of the original supplier, which is due or become due in future.
- 8. **Penalty:** Any supplier defaulted in supply will be subjected to penalty@ 0.5% per week of the order value, to be deducted from pending bills subject to maximum 10% of the ordered value for the particular item.
- 9. The Quantities mentioned in the Tender are purely tentative in nature, which may vary on either side as per actual requirement.
- 10. **Payment terms:** 100% payment will be released within 45 days of acceptance of the materials, by at par A/C payee cheque. The GST Bill in duplicate are to be raised along with the IBR certificate as per the Indian Boiler Regulation (IBR), 1950.
- 11. Complete set of Tender document, duly signed & sealed in each page is to be submitted as acceptance to all the terms & conditions of the Tender. In each Envelop there should be two separate sealed Envelops for Technical & Price bids.
- 12. In case of any dispute or differences pertaining to this tender, the Civil Courts at Bhubaneswar only shall have jurisdiction to entertain the same for adjudication.
- 13. The Managing Director, OMFED reserves the right to accept or reject either part/whole or any/all tenders without assigning any reason. The Federation may cancel or reduce the quantity of order or distribute/split the quantity to the other suppliers for which the lowest bidder/selected party will not be given any compensation. For any interpretation regarding this tender, the decision of the Managing Director, OMFED is final and binding.
