- 3) **Turnover**: Average annual turnover of at least ₹ 20 lakh during the last 3 financial years. Bidder has to submit the Chartered Accountant certified Turn Over statement for last three years i.e. F.Y 22-23, 23-24 & 24-25.
- 4) **IT returns certificate:** Copies of Income Tax Return acknowledgements for the last 3 financial years.
- 5) The copy of GST registration & PAN certificate.
- 6) The Firm/ Company Registration certificate.
- 7) **Fleet Details:** Bidder must own or have arranged minimum five (5) vehicles of capacity 2MT / 9MT / 16MT / 21MT / 25MT. For arranged vehicles, attach valid NOC from owners.
- 8) **Fitness & Vehicle Registration** of minimum 05 nos vehicles. The vehicle to be engaged must have valid fitness, Insurance, PUCC certificate. All drivers should have effective & Valid DL.

#### **A.** Important Notes for the Bidder:

- **2. Filling & Submission:-** Bidders shall read the tender carefully and ensure full compliance with all instructions. The filled-in Tender must be submitted along with Tender Cost & EMD in the form of separate DDs in favour of OMFED, payable at Bhubaneswar.
- 3. Submission of Tender document:- The prescribed tender documents should be submitted in one sealed envelope containing two bids i.e. Technical Bid and Price Bid in two separate envelopes super scribing respectively. The main envelope should clearly super be scribed on the top of the envelope "TENDER FOR ENGAGEMENT OF VEHICLES FOR TRANSPORTATION OF CATTLE FEED FOR CATTLE FEED PLANT, RADHADAMODARPUR, CUTTACK or JAGANNATHPUR, PHULNAKHRA, KHORDHA".

The following details need to be considered while submitting the tender documents:

- i. Price Bid- Price quoted to be submitted in separate envelope.
- **ii.** Information of Demand Draft Submission of: Tender cost of Rs. 11,800/- & the Earnest Money Deposit (EMD) Rs 2,00,000/- (Two Lakhs) for each Cattle Feed Plant.
- **iii.** The EMD shall not carry interest. It will be adjusted towards Security Deposit for successful bidders and refunded to others within 30 working days of tender finalization.
- **iv. Security Deposit is Rs 5,00,000/- (Five Lakhs)**. EMD of successful Bidders will be converted to Security Deposit and the balance amount of Security to be deposited before execution of operation in shape of DD drawn on OMFED payable at Bhubaneswar. The Security amount shall carry no interest and shall be refunded to the Transporter on a simple written application after successful and satisfactory completion of contract.
  - **v. Tender shall be rejected** if the Demand Draft/Pay order for the tender form fee and Earnest money are not found in proper order.
  - **4. Format of documents:** "Format of documents required for Technical Bid" should be duly ticked to ensure which documents have been enclosed (Page-14).
  - **5. Tender Box and Deadline**: Tender documents can be submitted through registered post, speed post, courier or by hand in the Tender Box at OMFED Corporate Office before the scheduled time. OMFED shall not be responsible for postal delay or loss in transit.
  - **6. Tender Committee**: -The duly constituted committee appointed by the competent authority shall open the Tender.

- **7. Acceptance of Bid**: OMFED shall not be bound to accept the lowest or any other offer. Incomplete, amended, late, or non-compliant tenders are liable for rejection without assigning any reason. OMFED reserves the right to make any changes in the terms and conditions of the bid. OMFED shall not be obliged to meet and have any discussion with any Bidder or to listen to any representations.
- **8. Short listing of Bidders**: OMFED will create a short list of technically qualified bidders, and the Price bid of only those bidders will be opened, who have qualified in Technical Bid. OMFED reserves the right to decide which offer best suits the requirements of OMFED. Further after opening the Price bid of the short-listed bidder, if there are any discrepancy between word and figure, the amount indicated in words will prevail.
- **9. Financial Capability:** -The Tenderer should have enough resources, financially sound and capability to transport Cattle Feed of 1700 MT (approx.) per month from Cattle Feed Plant, Radhadamodarpur, Khuntuni and 1500 MT (approx.) per month from CFP, Jagannathpur, Phulnakhra.
- **10. Conditional Offer**: Conditional, incomplete or unsigned bids shall not be accepted and are liable for rejection.

#### 11. Rejection of Bids: -

- i) Incomplete bids are liable to be rejected.
- **ii)** Canvassing in any form in connection with the Tender is strictly prohibited and the bid submitted by the bidder who resort to canvassing are liable for rejection.
- **iii**) Non-signed Tender bids, unattested correction and over writing by bidder are also liable for rejection.
- iv) Bids submitted without supporting documents as mentioned or required to be submitted with bids are liable to be rejected.

#### **B. Information / Documents Required for Submission of Technical Bid:**

Technical Bid should contain information regarding the company/Firm, its registration details, client list, Performance certificate given by clients if any, Self-declaration of not being black-listed, business turnover, experience and other details of the Firms to judge the suitability of the Bidder. Bidder must ensure the following conditions while going for the bidding.

- i) Bidders are submitted all the documents in the technical bid as per "ELIGIBILITY CRITERIA FOR QUALIFICATION" clause at Page no.5
- ii) The existing Transporter of OMFED Cattle Feed Plants has to submit obtain **Performance Certificate** from the concerned Plant Managers.

#### C. Information /Documents Required For Submission Of Price Bid:

- 1) Commercial Bid/Financial Bid/ Price Bid are same. Price Bid should contain the quoted price for different km structures towards delivery of Cattle Feed at different delivery points throughout Odisha to be provided by OMFED along with the Tender form.
- 2) All rates quoted should be given in figures and words.
- 3) Rates must be quoted as per distance slabs specified (Up to 50 km, 51–150 km, above 150 km) for each vehicle capacity, as per km/MT. The km rate is linked with the diesel price on pro-rata basis.
- **4)** The Successful Bidder must execute an Agreement in non-judicial Stamp Paper worth Rs: 20/-within 15 days from placement of the Order.
- 5) The quoted rate should be inclusive of all charges such as Insurance, Tollgate & other taxes etc.
- **6**) The rate quoted by the Bidder shall be valid for a period of Three years.
- 7) Price Bid must not carry any condition or deviation from tender terms. Conditional Price Bids will be rejected.

#### **D. Terms & Conditions of the Tender:**

- (1) Validity: The rate quoted by the Bidder shall remain valid for Three years for both Plants. Initially it will be for One year & next two year considering the Performance Certificate of the transport contractor.
- (2) Price: Price stated in the Tender are firm and shall remain firm and linked only to diesel price on prorata basis.
- (3) Places: The places of delivery point mentioned in the Tender document are tentative. OMFED reserves the right to increase, decrease, or alter delivery points during the contract period depending upon operational needs.
- (4) Acknowledgement and acceptance of Agreement: This agreement constitutes an offer from OMFED and is expressly limited to the Terms and conditions contained herein. The Terms and conditions of the agreement are those that apply to the engagement of vehicles for transportation of Cattle Feed.
- (5) The Bidder as an Independent Contractor: The selected transporters shall perform the delegation of this order as an independent contractor and under no circumstances shall it be considered an agent or employee of OMEFD.

#### (6) Delivery/Risk:

- (a) The selected transporter makes all arrangements at their own risk for Safe delivery of the Cattle Feed at the destination point.
- (b) The selected transporter shall arrange to place their vehicles at plant as per scheduled period assign by concerned Plant Managers, if transporter failed to provide vehicles on schedule time, the penalty will be imposed @ Rs 1000/per Truck for 24 Hours.
- (c) The delivery of Cattle Feed is to be made as per schedule to be provided by the Plant Manager Cattle Feed Plant, Radhadamodarpur and Jagannathpur to the selected bidders Any delay in delivery will lead to forfeiture of Security Deposit along with Penalty as deemed fit. OMFED reserves the right, without liability to cancel the order.
- (d) In case of receipt of the material in short supply or damaged condition at the receiving point, the cost of damaged material or the cost of material short supplied will have to be recovered from the bill of the Transporter.
- (e) The risk of safe delivery started soon after loading & acknowledgement signature of transporter in the challan till delivery of feed.
- (f) In case selected transporter is unable to provide required capacity of vehicle on schedule period for dispatch of Cattle Feed/Inter Plant Transfer (Mineral Mixture, Other Raw materials) etc., then OMFED will arrange alternative transportation and the differential transport charges of that consignment will be recovered from transporter.
- (g) During Natural Calamities like Flood, Cyclone, Drought etc., the bidders have to provide adequate numbers of vehicles for transportation of Cattle Feed. For any delay/detention charges of vehicle at delivery point the detention charges @ Rs 1000/per Truck for 24 Hours will be paid by producing the due acknowledgement of the receiving authorities.

- (h) Any instance of vehicle breakdown en route must be immediately informed to the Plant Manager and alternate arrangement made by the transporter within 12 hours.
- (7) Assignment/ Sub- Contracting/ Sublet: The selected transporters shall not assign/ sublet/ sub- contract a part or whole of the order.
- (8) OMFED reserves the right to engage more than one transporters in each plant for smooth dispatch the cattle feed.
- (9) Cancellation: OMFED reserves the right to accept any bid or to reject any or all bids or to annul the bidding process of all bids at any time prior to holding of tender or award of contract without there by incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder(S) of the ground for such action. OMFED may cancel the agreement entered in to with the bidder in whole or in part without assigning any reason, upon written Fax, E-mail notice to the bidder effective from the date of issuance, provided such notice is sent 10(ten) days prior to the initial effecting date of the validity period specified in the order placed.
- (10) Dispute Redressed Mechanism: In case any dispute arises from/in connection with this present contract, the decision of the Managing Director, OMFED, shall be final and binding and shall not be questioned in any court of law.
- (11) Payment: 100% payment to be made once in a month before 15<sup>th</sup> of every succeeding month only when the CMR, bills, challans of the previous month received within the first week of the succeeding month. The payment shall be made by way of Account Payee Cheque/RTGS. GST will be exempted from the transportation bills. E-waybill to be provided by the Cattle Feed Plants during the time of dispatch. The payment will be made to the Transporters based upon:
  - i) **Up to 50 km** Fixed amount for 2-3 MT/09-10 MT/16-17 MT/20-21MT/24-25 MT.
  - ii) Above 50km up to 150 -On actual km, covered per km/MT basis.
  - iii) Above 150 km- On actual km, covered per km/MT basis
- (12) Transportation, Packaging, and Insurance: All Cattle Feeds delivered through the Vehicles to be ensured for its safe delivery in accordance with good commercial practices. Transportation of Finished goods to be insured by the Cattle Feed Plants.
  - i) The trucks are to be fully insured to the values of the vehicles & cargo against any type of risks at the expense of the agency & no liability will be attached to OMFED in this respect.
  - **ii**) The drivers of the trucks and the assistants, if any are also to be insured in accordance with laws whichever is applicable & no liability will be attached to OMFED in this respect.
  - iii) Copy of insurance certificate for all vehicles must be submitted at contract signing and kept valid throughout contract period.

#### (13) Operations:

- i. All operations of the agency are to be conducted in a safe manner and in compliance with all Central, State & Local Laws, Statutes, Ordinances, Standards, Rules and Regulations.
- ii. The agency shall provide roadworthy vehicles in very good condition and well maintained for transportation of products to the designated locations.

- iii. The vehicles shall remain in sound working condition and be dust proof. Its emissions shall comply with pollution control norms. All the expenses incurred in the maintenance of the vehicles or otherwise shall be borne solely by the agency.
- iv. All related and relevant documents of the vehicles should be available in the vehicles while on duty.
- v. The drivers shall possess valid & effective Driving License, should be well behaved and punctual and while on duty, they should never be intoxicating state or smoking.
- vi. The driver shall not be reluctant to or deny or refuse to go to any place including various destinations as listed in the scope of work. In case of stay anywhere, they shall be required to make their own arrangements for food and stay. OMFED shall not provide any additional remuneration monetary or otherwise in any such situation.
- vii. In case the vehicle is not available for whatsoever reason, OMFED shall be free to make its own arrangement at the sole risk and cost of the agency. Any expenses thus incurred shall be deducted from the amount payable to the agency.
- viii. The agency shall ensure immediate replacement of a vehicle due to its being involved in accidents, mishaps or any such circumstances and shall inform OMFED about such eventualities without any loss of time.
  - ix. The agency is responsible to provide fuel, oil, tiers and other parts, supplies and equipment necessary or required for the safe and efficient operation and maintenance for all his vehicles for transport of products allocated.

#### (14) Performance Clause:

- i. The vehicles and the drivers shall provide satisfactory service at all times during the entire contract period as per the provisions of the contract. Failure to comply with the provisions of the tender document will be considered as unsatisfactory performance.
- ii. Contract may be terminated in case of prolonged/ frequent unsatisfactory service, breach of terms and conditions and non-compliance by the agency of the instructions given by OMFED officials. In case of termination of the contract, Performance Security deposited by the agency shall be forfeited.

#### **E. General Terms & Conditions.**

- (1) The Tender documents shall be sealed and addressed to the Managing Director, The Odisha State Cooperative Milk Producers Federation Ltd., D-2, Sahid Nagar, Bhubaneswar 751 007 in block capital letters clearly indicating the tender reference and date of opening at the top of the envelope.
- (2) Agreement Execution: The successful Bidder shall collect Model Agreement Papers from the Plant Manager, Cattle Feed Plant, Jagannathpur to be typed on Non-Judicial Stamp Paper of Rs 20/-.
- (3) Federation reserves the right to appoint More than one Transporter Contractor for smooth transportation of cattle feed to different destinations under different Milk Unions.
- (4) The Bidders shall not be allowed to use his own discretion in any respect once the order is placed and agreed for execution.
- (5) On finalization of the rate, a work order shall be issued to the transporter. The acceptance copy of the work order must be sealed and signed by the bidder as token of his acceptance of the Order along with terms and conditions specified therein. If the order is revoked by the transporter in any case, the EMD is liable to be forfeited.
- (6) Co-Operatives, Govt. bodies, NSIC and MSME registered firms are exempted from submitting required EMD.
- (7) The Federation reserves the right to engage vehicles in other routes when necessary. For any addition or alteration, distance freight will be increased and decreased accordingly.
