SCHEDULE – I

The Odisha State Cooperative Milk Producers' Federation Ltd. (OMFED) invites sealed offers from bonafide manufacturers/association of such manufactures and their authorized representatives for conversion of milk to Skimmed Milk Powder (SMP), Whole Milk Powder (WMP) & Ghee, as per detailed specifications given in the Schedule-II & Schedule-V of the offer.

1.0 ELIGIBILITY CRITERIA

- 1.1 The bidders should have similar type of minimum two years of experience in conversion of milk to SMP/WMP/Ghee with other Cooperatives/Private Sector. (Attach work order/ Agreement copy)
- 1.2 The bidders must have having capacity of minimum 10 MT powder plant. (Attach details).
- 1.3 The bidders must have BIS/ISO certification and FSSAI Licence. (Attach certificate)
- 1.4 The average annual sales turnover of the bidder should not be less than Rs. 3.0 Crore for the last three financial years starting from 2022-2023, 2023-2024 and 2024-2025
- 1.5 The bidder shall furnish a copy of the Income Tax return for the financial year 2022-2023, 2023-2024 and 2024-2025.
- 1.6 The bidder should have required mechanism with experience Technical Manpower to run Milk Processing, Powder, and Ghee Plant etc. (Attach manpower details)
- 1.7 The bidder should have sufficient storage facilities for Milk, Milk Powder, Ghee. (Attach photo of Go down).
- 1.8 The bidder must be having equipped Testing Laboratory / facility to test milk, Milk Powder and Ghee. (Attach details of Lab equipment).
- 1.9 The bidder shall also provide their permanent A/c No. Income Tax (PAN).
- 1.10 The bidders must have GST registration.
- 1.11 The bidders should not have blacklisted from any co-operative/Govt. sector.
- 1.12 The bidders must have submitted the proof of above Sr no 01 to 12.

2.0 OFFER SUBMISSION:

- 2.1 The offers should be submitted within scheduled time & date.
- 2.2 Tenders shall be submitted in sealed envelopes separately for Technical & Commercial.
- 2.3 The offers received through Fax/E-mail will not be considered.
- 2.4 The rates should be quoted in prescribed format only.
- 2.5 The party should clearly mention the correspondence address, fax/e-mail/ telephone nos.
Any change in the address should immediately be notified to the OMFED and correspondence thereafter will be made at the changed address.
- 2.6 Individual submitting the offer and other related documents must specify whether he has submitted as the sole proprietor of the firm or constituted attorney of such proprietor.
A partner of the firm, if it is partnership firm in which case he must have authorities to refer to the arbitration disputes concerning the business of the partnership either by virtue of partnership deed or by Power of Attorney.
As director of a Company, if it is a company incorporated under Company Act 1956/2013, copy of the Board Resolution authorising the Director to act on behalf of Company.

3.0 EARNEST MONEY DEPOSIT:

- a) Cost of tender paper Rs.7080.0/- including GST & EMD of Rs.5,00,000/- shall be deposited through online portal at **<https://tendersodisha.gov.in>**.
- b) The bid security is required to protect the OMFED against the risk of bidder's conduct, which would warrant the security's forfeiture.
- c) The EMD of the technically disqualified Bidders shall be returned after declaration of the list of such technically qualified Bidders in the portal.
- d) The EMD of other unsuccessful Bidders shall be refunded after signing of the Agreement with the Successful Bidder. The return of the EMD shall be in the form of bank transfer to the account of the Bidder through the e-procurement portal of the Government of Odisha.
- e) The EMD of the successful Bidder shall be returned after furnishing the bank guarantee.
- f) Co-Operatives, Govt. bodies, NSIC and MSME registered firms are exempted from submitting required EMD.

- g) Bank Guarantee worth Rs.1.0 Crore is to be submitted by successful bidders along with agreement to OMFED.

8. Penalty:

In the event of bidder fails to execute the work within the scheduled period, OMFED reserves the right to impose the penalty as decided by the Authority and also forfeit the EMD/Security Deposit.

9. Disputes:

- The Federation and the bidder shall make every effort or solve any dispute/disagreement in connection with the bid amicably by direct negotiation. However, the decision of Managing Director, OMFED will be final & binding in case the disagreement or dispute is not resolved by mutual negotiation.
- Legal dispute if any, concerning to this job shall be subject to the court having jurisdiction at Bhubaneswar only.

PRICES:

- 4.1 The rates offered shall be valid for a period of 01 year from the date of tender.
- 4.2 The offered price should be firm, clear and free from any escalations during the validity period.
- 4.3 The tenderer should quote rates for conversion charges & transportation charges on the basis of per kg. manufacturing, packing, storage and handling of SMP & Ghee. The tenderer will also include rate to return converted materials to Bhubaneswar dairy/ OMTDC/ any processing plant of OMFED. OMFED shall supply milk from different Plants (Bhubaneswar, Balasore, Sambalpur and Bhawanipatna) and SMP & Ghee will be received after quality checks. If any material found substandard, it is to be lifted at their own cost.
- 4.4 Rates should be quoted on the basis of strict adherence to specifications of SMP and Ghee and recovery norms of FAT and SNF as given in Schedule –II and should be quoted inclusive of all taxes and duties, if any.
- 4.5 The rates offered shall be inclusive of all taxes & duties.

5.0 INSURANCE:

- 5.1 Necessary transit insurance shall be arranged by the bidder for lifting milk for conversion and returning back of the finished products.

6.0 PAYMENT:

- 6.1 90% Payment (conversion charges) shall be released within 30 days after receipt of converted materials at our plants.
- 6.2 100% payment of transportation shall be released within 30 days.
- 6.3 All Payment shall be made through RTGS/NEFT after realisation of Bank charges from party's dues.
- 6.4 All payments are subject to deduction of statutory duties as applicable.

7.0 GENERAL TERMS & CONDITIONS:

- 7.1 **The acceptance of the offer and award of the work order shall be the sole right of the MD, OMFED, who does not bind himself to accept any offer in whole or in part or reject any or all offers received without assigning any reasons and no explanation can be demanded of the cause of rejection of the offer by any of the tenderer.**
- 7.2 **Negligence on the part of the tenderer in submission of the offer confers no right to withdraw the offer after it has been opened. If the successful tenderer fails to accept milk and fails to make SMP/Ghee within the stipulated period mentioned in work order without any valid reason, then the order shall be treated as cancelled and EMD/SD/bills lying with OMFED would be forfeited and the firm may even be blacklisted.**
- 7.3 **OMFED reserves the right to place order for** conversion of entire quantity of milk with any party or split the order among two or more parties.
- 7.4 The submission of a tender by a party implies that the firm has read the notice and terms and conditions of tender and has made himself aware of the scope and specifications of the work to be carried out.
- 7.5 Milk shall be supplied to conversion plant if there is any emergency breakdown and surplus milk available beyond the installed capacity at OMFED Dairy, Arilo-Govindpur during pick milk flush season i.e. from mid of April to mid of September.
- 7.6 If required, Omfed may do the cream separation and we may send skim milk or partial fat in milk for Powder conversion.
- 7.7 The bidder firm shall not contract or assign (sublet) the work to any other party or party's firm the whole or any portions of the offer awarded by OMFED.

- 7.8 Conversion plants will ensure hygienic and sanitary condition for storage of SMP and Ghee on plastic planks/pallets in clean and dry place away from sunlight. The place should be free from dust and pest/rodent environment. The deep freeze to be used for storage of WB should essentially be fumigated prior to its use.
- 7.9 If required, OMFED may send its own tanker for lifting loose ghee, or OMFED may ask the bidder to dispatch the ghee in their tanker, subject to payment of transportation charges at the prevailing milk transportation rate.
- (a) The bidder should return the all converted materials to Omfed when the stock position reached to one truck load i.e. 16 – 25 MT within one week,
 - (b) Otherwise the bidder will be paid penalty @ Rs. 0.10 per KG of converted SMP & GHEE on each day late for fail/disobey fully / any part of the converted material return schedule.
 - (c) In case of requirement of ghee at OMFED, loose ghee may be transported in a milk tanker at the same rate as applicable to milk tanker transportation.
- 7.10 The packing materials used for packing should be of “OMFED” brand, with OMFED logo
- 7.11 The L1 bidder should sign the agreement and furnish the Bank Guarantee within 15 days from the issue of work order, failing which it is deemed that the work order is not accepted and it will stand cancelled automatically.
- 7.12 The bidder should understand and accept that Milk is a perishable essential commodity. Therefore, milk shall be transported within the shortest possible time. On an average, subject to no entry conditions, and the like, the milk tanker should cover minimum 30 K.M. per hour. If partial tanker is sent, the minimum speed limit shall be 25 km/ hr. However, in case any tanker takes more time for covering less distance the transporter will be solely liable for any or all the loss and damaged caused including those arising due to rejection of milk at the destination point. Accordingly, the tanker should ply continuously to the destination once it leaves the Dairy Plant premises by maintaining the aforesaid average speed and should not make unnecessary halt/delay in transit. The company shall have discretion to put penalty on delay in travel time.
- a) More than 2 hours, with no effect on quality: Rs. 200 per hour.
 - b) More than 2 hours with adverse effect on quality: Penalty up to total recovery of losses.
 - c) Further, the transporter has to follow the route prescribed strictly, except otherwise under compelling circumstances.

- 7.13 If minor documents are missing or not uploaded by the bidders, they may be asked to submit the same through e-mail or courier, with the knowledge of the Purchase Committee members.

8.0 QUALITY CHECKS/ PARAMETERS:

- 8.1 The successful tenderer shall have to carry out job in strict under hygienic & sanitary environment conforming to the basic standards laid down under Food Safety & Standards Act 2006 and other rules and regulations prevalent. Violation of any clause of different Acts shall be the sole responsibility and liability of the successful tenderer.
- 8.2 SMP & WMP shall have to be manufactured confirming to BIS standard and Ghee as per “AGMARK” specifications and recovery norms of Fat and SNF as given in Schedule II of the tender document.
- 8.3 The successful tenderer shall ensure the availability of all manufacturing and testing facilities at the factory premises and maintain them properly including their calibration and stamping at regular interval to ensure precision testing.
- 8.4 The Bidder shall be held responsible for the losses in Fat & SNF due to testing/ weighing variations of Fat%, SNF% and quantity of milk at dispatch and receipt of milk at the Plant. The Transporter shall be allowed a maximum negative variance (loss) on quantity of Fat and quantity of SNF in the monthly billing cycle as under.

A maximum of 1.0% loss in term of total quantity of Fat dispatched (Kgs of Fat) and a maximum of 1.0 % loss in terms of quantity of SNF dispatched (Kgs of SNF) shall be allowed, during the monthly compilation. Any loss over and above limit shall be deducted from the monthly transportation bill of the Transporter. The positive or negative variation in quantity of milk are included in this method of calculation of loss/ gain of quantity of milk FAT/SNF, so no additional variance in quantity of milk shall be allowed. The gain, if any in monthly total quantity of milk Fat and/ or SNF shall not be considered for any payment to the Transporter. The gain in one component (Fat/ SNF) shall not set off loss in other component (Fat/SNF).

In case of variation at destination at the time of receiving is noted due to technical error, the Transporter shall inform the Plant Manager and then the Dairy Operation Division shall take up the matter with the dairy unit at destination point and if found correct, there shall be no deductions from transporter's bill.

- 8.5 For the processing losses maximum 1.0% will be provided as a Total Solid loss. And after the excess loss, it will be recovered from the bill.
- 8.6 The authorized representative of OMFED shall inspect the premises in regard to sanitation and hygienic practices and conditions as well as the records regarding the quality of raw milk, quality and manufacture of Ghee and SMP as well as packaging materials and packaging practices and or as may be directed to inspect by the company.
- 8.7 Bidder has to depute one Quality Control Officer at Milk Loading dairy. He will confirm the quality (Fat and SNF) before tanker dispatch. After dispatch of Milk tanker, if there is theft on the way or receive less fat & SNF, it is a responsibility of bidder.

9.0 INSPECTIONS:

- 9.1 All SMP/Ghee produced shall be subject to inspection prior to acceptance. In case the SMP/Ghee is rejected on quality grounds, the successful tenderer shall be required to manufacture and supply an equivalent quantity of SMP/Ghee from their own resources strictly as per the prescribed standards. In such cases, the landed cost of milk supplied by OMFED shall be recoverable from the successful tenderer. The inspection report of the concerned Milk Unit in this regard shall be final and binding.
- 9.2 OMFED shall dispatch the milk tanker along with Milkoscan/Indifoss test results and invoice Copy or challan copy, including all relevant quality, testing, and adulteration parameters.
- 9.3 After conversion at the bidder's premises, all Ghee shall be tested and certified as GC-pass and free from all forms of adulteration, and SMP test reports shall conform to BIS specifications. Further, OMFED shall send samples of the produced Ghee and SMP to a NABL-accredited laboratory for testing. Acceptance of the material shall be subject to satisfactory test results from the NABL laboratory.

10.0 TERMINATION OF CONTRACT:

- 10.1 In case of any act of commission or omission of conversion plant violating the terms and conditions of the contract, OMFED shall be competent to debar/blacklist the conversion plant from further business and Security Deposit also shall be forfeited.

11.0 CONSEQUENCES OF BREACH OF AGREEMENT:

- 11.1 If the authorized person of the conversion plant or a partner in the contract/tendering firm commit breach of any of the conditions of agreement, it shall be lawful OMFED to cancel the contract and recommend for forfeiture of the Security Deposit lying with OMFED.

1. Acceptance of work, Signing of Contract, Submission of Security Deposit & Start of work.

- (i) Technical bid acceptance will be notified on e-tender web site. OMFED, Bhubaneswar will send the successful bidder the order copy & execute Contract agreement incorporating all agreements between the parties. The order copy also forms part of the contract document, and you are requested to sign the order copy sent in confirmation of your concurrence and return it to the office of the Managing Director, OMFED. within 10 days of order, failing which it would be deemed that you are not interested in the work and action as per contract conditions will be taken.
- (ii) The Bidder shall submit the contract of agreement along with the security deposit on a stamp paper of Rs.1,000/- in a prescribed form duly signed by the Authorized Official to Managing Director. OMFED.
- (iii) The earnest money deposit submitted along with the tender by the successful bidder will be converted into Security Deposit and shall be returned after successful execution of contract during contract period. Unsuccessful bidder's EMD will returned as per provisions of e-proc website through www.tenderodisha.gov.in web site.

2. CONDITIONAL TENDERS: -

All conditional tenders / quotes which are in contravention to OMFED, Bhubaneswar contract conditions will be rejected.

In case of non-deposit of EMD & Cost of Tender Documents, the Bid shall be rejected.

In case of non- qualification or non-submission of the required documents as per PQ criteria, the Bid may be rejected.

However, an undertaking is to be given in technical bid that no conditions are imposed in their bid.

Articles of Agreement made this.....day of..... two thousand and

BETWEEN

THE ODISHA STATE COOPERATIVE MILK PRODUCERS' FEDERATION LTD. an apex cooperative society registered under the Orissa Cooperative Societies Act, 1962, having its Corporate Office at D-2, Saheed Nagar, Bhubaneswar-7 (hereinafter referred to as “**Federation**”) which expression shall unless repugnant to the context or meaning thereof, include the successors in interest and assigns of the Federation of the ONE PART

AND

M/s -----(Name of the Conversion Agent) a Company registered under the Indian Company Act-1956 having its registered office at:- ----- and Works/Factory at ----- (Hereinafter referred to as “**The Conversion Agent**”) which expression shall unless repugnant to the context of meaning thereof, include the heirs, executors administrators and legal representatives of Lessee) of the OTHER PART.

WHEREAS the Federation, engaged in the business of production, processing and marketing of milk, milk products and agri-products is in need of a conversion agent having required processing and manufacturing facilities for conversion of its' surplus whole-milk to SMP , WHITE BUTTER & GHEE on requirement basis.

AND WHEREAS the OTHER PART having required infrastructural facilities at Works/Factory at ----- has offered to act as Conversion Agent to meet the requirement of the Federation on the terms and conditions mentioned hereinafter.

NOW THEREFORE, IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS.

01. That the agreement shall remain operative during the flush season of milk production in Odisha as long as surplus milk is available with OMFED during the year 2026-27.
 - a) That the Federation shall supply pasteurized good whole/Skimmed Milk from OMFED plants in insulated Milk Tanker of Conversion agent for immediate conversion of the same to SMP, WHITE BUTTER & GHEE as per recovery norms stipulated herein.
02. That the Conversion Agent shall arrange for conversion of milk to SMP, WHITE BUTTER & GHEE as per recovery norms specified below:

i) Recovery From Whole Milk Fat to White Butter Fat : 99.00%

- ii) Recovery from White Butter Fat to Ghee : 99.00%
- iii) Recovery from Whole milk SNF to SMP : 101.50%
- (Including maximum 3.5 % moisture)
- iv) Recovery from Skim Milk SNF TO SMP : 101.70%

(Including maximum 3.5 % moisture)

03. That the Conversion Agent shall ensure that the converted products should be of following specification:

A) SMP must be BIS/ISO Mark Grade and should not contain more than 3.5% moisture and ash content should be within range of 7.7% to 8.2 %.

B) Cow Ghee :

Appearance / Description: Slight yellow in colour & free from any extraneous matter

1. Moisture % W / W max. : 0.3% maximum.

04. In case of receiving substandard milk from OMFED, the quality clause & the yield % thereof may be changed. The quality & quantity of S.M.P. & Ghee be finalized by the mutual consent of both the representatives present at the factory of the conversion agent. In case of receiving substandard milk from OMFED it is requested by the OMFED to the Conversion Agent's to make their best effort for conversion of S.M.P. & Ghee. Otherwise both the representative have to take immediate following decision with mutual consent as the milk is highly perishable & leads to loss.

- a) Convert the substandard milk to S.M.P. & Ghee with extra cost (as applicable) decided mutually.
- b) In worst case, the FAT be separated for ghee production & drained out the skimmed milk in presence of both the representatives with authenticity. Cost of Milk separation (Rs. / Kg. of milk) & cost of disposal of effluent (Rs / Kg. of milk) generated by drainage of skimmed milk will be charged separately.

05. That the federation shall deploy one quality control personnel in the Dairy of Conversion Agent for jointly test checking of raw milk and converted products as well. The Federation agrees for quality parameters / quality of raw milk received at Conversion Agent's Factory at _____ which has been tested in his presence. Further, the processed quality of SMP / Butter / Ghee and the quality parameters to be checked and released for dispatch. Conversion Agent shall not entertain any claim on quality on the post dispatches.

06. That the Federation shall make payment of conversion charges on receipt of full truck load of materials (SMP, WMP & Ghee) from the factory of the Conversion Agent as per indent from time to time at the rates indicated hereunder. (inclusive of all Taxes as applicable)

- A) Manufacturing Charges of SMP per KG: Rs. ____ /-
- B) Manufacturing Charges of WMP per KG: Rs. ____ /-
- C) Manufacturing Charges of Ghee per Kg : Rs. ____ /-
- D) Packing Material Charges of SMP: Rs. ____/- Per Kg
- E) Packing Material Charges of WMP: Rs. ____/- Per Kg
- F) Packing Material Charges for Ghee per Kg : Rs. ____/- (Packed in 15Kgs tin)
- G) Milk transport cost : Rs. ____/- per Kg

 - The Conversion Agent shall raise the bill at the rate applicable. Taxes extra.
07. That the Federation shall make full payment of conversion made and storage charges on receipt of stock from the Conversion Agent's Factory, subject to test checking of quality and receipt of bill/s thereof.
 08. The bidder will be paid penalty @ Rs. 0.10 per KG of converted SMP & GHEE on each day late for fail/disobey fully / any part of the converted material return schedule.
 09. The Conversion plant shall make necessary arrangement for delivery of converted products at the OMFED plant as per the schedule to be intimated and the cost of transportation shall be borne by the Conversion plant subject to delivery of stock not intact at the time of unloading. Before the loaded vehicle leaves for Federation's Dairy the conversion agent shall intimate the details for the delivery challan, quantity, value, vehicle no., etc. by mail or fax.
 10. Necessary transit insurance shall be arranged by the bidder for lifting milk for conversion and returning back of the finished products.
 11. In case of any disputes between the parties in relation to this agreement touching the business of the parties, the disputes shall be referred to an arbitrator to be appointed by mutual consent of both the parties. The award of the Arbitrator so appointed shall be final, conclusive and binding on all the parties to the Agreement and provisions of the Arbitration & Conciliation Act, 1996 or any statutory modification or re-enactment thereof and the Rules made there under and for the time being in force shall apply to the arbitration proceedings under this clause.
 12. This Agreement has been made in Bhubaneswar and the parties hereby agree that the Courts in the city of Bhubaneswar alone shall have jurisdiction to entertain any application or other proceedings in respect

of anything arising under this Agreement and any Award or Awards made by the Sole Arbitrator hereunder shall be filed in the concerned Courts in the city of Bhubaneswar alone.

13. This Agreement sets forth the entire agreement and understanding between the parties to the subject matter and neither party shall be bound by any condition or understanding or representation with respect to the subject matter of this Agreement except as duly set forth on or subsequent date hereof in writing and signed by the party or by a proper duly authorized representative. Further all provisions of this Agreement are severable and invalidity of any provision in this Agreement shall not affect all other provisions, which will remain valid and binding.

14. This Agreement is liable to be terminated by either party on the happening of the following events:

- a) If there is a breach committed by either party of terms & conditions of this agreement and if the defaulting party does not rectify such breach within 30 days of the intimation of such breach of the defaulting party.
- b) If any of the parties is declared bankrupt and become insolvent.
- c) On mutual written consent from both the sides.

15. **Other General Conditions-**

- a) It is fully understood and agreed between “The Federation” and “the Conversion Agent” and that this Agreement has been signed for the sole purpose mentioned above and this Agreement in any event, save for what is mentioned therein, will not confer any right to either of them against other.
- b) The parties of the Agreement will not initiate any communication with or provide information to any other party with respect to the discussions held between themselves or the contents of this Agreement without written consent of the other party.
- c) The conversion agent will not divert the milk or converted stock anywhere without the consent of the Federation.
- d) The conversion agent shall update the Federation about the accumulation of stock twice in a week.
- e) All notices, requests, demands and other communication required or to be provided for under this Agreement shall be given in writing and shall be delivered to the respective addresses of the parties here as under:
